President Bong reminded trustees of the Special Town meeting to be held Thursday night to discuss and inform concerning the lead and copper exceedance letter from IEPA.

Attorney Wherry presented to the board a skeleton resolution, which, when completed, will provide for the reimbursement of General Funds which may have been or will be used to finance water and sewer infrastructure projects. Eric Hansen has created a listing of present day values for sanitary sewers, water lines, storm sewers and streets etc. to aid in evaluating courses of future action regarding projects as well as costs.

Based on Eric Hansen's projections, President Bong asked trustees Scranton and Getz and their committees to begin creating a plan of action regarding the update and improvement of Village infrastructure. Once a plan is in place, the Board will decide upon financing options. Wherry's reimbursement resolution should be passed regardless of the Board's financing decision.

Trustee Zuercher moved to approve a contract extension with *CMT Engineering* from the present until the end of the fiscal year, April 30, 2017, for the cost of \$10,417. Replogle seconded.
