Trustee Zuercher moved to approve the minutes for the regular meeting of March 4, 2019, and Scott seconded.

Attorney Dick Wherry presented copies of **Ordinance 19-103** (now finalized) which was passed by the Board at the March 4 meeting.

Attorney Dick Wherry swore in Robert Siwak as our new full time police officer. Siwak, who had worked previously in Winnetka, Illinois, will begin his training tomorrow with Police Chief Mike Dodwell and Captain Nate Troyer. Welcome.

Following a short presentation by Heidi Henderson, Trustee Harding moved to approve the Grade School 5K and mile run event and route. The route will be the same used the last few years and the event will take place on Saturday, April 13, at 9:00 AM. Replogle seconded.
