Trustee Zuercher moved to approve all bills incurred since March 20, and Scott seconded.

Trustee Harding moved to transfer \$9227.43 from General Savings to Police Operations Checking to cover bills and payroll. Zuercher seconded.

Trustee Scranton announced that the Water & Sewer Committee will meet Thursday night April 13, at 7:00 PM.

Trustee Zuercher moved to approve **Ordinance 17-102** amending the Zoning Code in regard to "Lot" definition. Scranton seconded.

Trustee Scranton moved to approve **Ordinance 17-103** amending the Water & Sewer Base Rates.

Trustee Zuercher moved to approve **Ordinance 17-104** amending Designated Area as an Enterprise Zone and Related Matters under Section 5 of the Enterprise Zone Act. Harding seconded.

Police Chief Mike Dodwell reported that Tremont is now a licensed Bassett provider and will have two licensed instructors. Class dates will be available soon.

Chief Dodwell also presented a list of 14 unmarked intersections to be reviewed by the Board for the purpose of placing traffic signs at the most hazardous. No action was taken at this time.

Josh Weer, whose variance request for the property at 325 N. Locust Street was denied by the Zoning Board, was present to explain what his plans were for the property and to hear any alternatives the board might provide.

Trustee Scranton moved to table any action on Weer's request so that the Village Board might further review the situation. Scott seconded.

Mike Vonderheide and Brian Vonderheide presented a short overview of their tentative plans to build a two-story townhouse complex at the property on Route 9 at Harris St. The property would have to be rezoned to *R-3* from *Commercial*.

President Bong reported that the Park District had received a complaint by the *ADA* identifying the parks and sport facilities in the Village of Tremont as being in violation. This includes the School District as well as the Park District which merely leases the parks from the Village (which, in turn, makes the Village liable). The ADA is urging handicap accessible walkways, ramps, slabs and restrooms. The Village hopes to write up a plan of compliance to be submitted to the ADA.
